Terms & Conditions

1. Services: By signing this agreement, you authorize this business to (a) receive and store your items (goods), (b) list, offer and sell goods on-line for you (c) deliver goods to buyer, (d) collect sales price from buyer, (e) deduct our fees and cost, and/or (f) forward the remainder of sales price to you.
2. Binding Bids: You must honor our sale to the highest bidder/buyer, if any, upon the listings completion, unless the bidder/buyer fails to pay for the goods.
3. Unsold Goods: If the goods are not sold for any reason, you authorize us to do any of the following (a) vary sales term with your permission (b) dispose of the unsold goods (c) you agree to retrieve them within (10) working days after our request to pick them up. If you do not pick up unsold goods within that period, we may dispose of them.
4. Payment to Seller: As consideration for services described in paragraph 1 ("services"), you agree that we are entitled to collect the service fee described on the reverse side of this page and forward the balance of profits from sale of your item within (30) days from the date we receive proceeds of sale.
5. Title and Risk of Loss: You retain title to the goods until the shipper chosen by us actually delivers the goods to the buyer upon delivery, title passes directly from you to the buyer. You are solely responsible for any loss or damage to the goods for any reason including criminal acts, until buyers obtains title. You accept responsibility for insurance coverage and agree that a loss or damage may nullify a sale.
6. Your Warranty of Goods: You warrant that (a) you have the right to authorize us to offer, sell and delivery of goods to any third part, (b) the description of the goods is truthful. You also warrant that the goods are not counterfeit or stolen.
7. Indemnify: You agree to idemnify, defend and hold us harmless from any claim, judgement, loss or demand, known or unknown, foreseeable or unforeseeable, including reasonable attorney's fees, made by any third party against us in connection with, related to or in any way arising out of this agreement, except for losses, caused solely by our gross negligence.
8. Waiver of Damages: Our liability for loss or damage to the goods is limited to the lesser of \$500 or the fair market value of the goods. In no event will we be liable to you for any incidental, consequential, exemplary, indirect, special or punitive damages arising out of or connected with this agreement or it's termination regardless of the form of action and regardless of whether we have been advised of the possibilty of any such loss or damage.

FREQUENTLY ASKED QUESTIONS:

***How much does it cost ?**

We charge 40% of the selling price plus any eBay and payment charges (ex. PayPal)

***How long do you list my item for sale on eBay ?**

Typically, it takes a (7) day auction to maximize bidding interest. If the item doesn't sell, it's relisted asecond time for **free!**

***What if my item doesn't sell after the 2 auction periods ?**

If your item doesn't sell, you will be notified via email and can pick it up within (10) days of auction closing or we'll donate your item to charity.

***How large and how heavy can the item be ?**

All items must weigh less than 150lbs. and must not exceed 130" combined length, width and depth.

All items must be legal for sale on eBay (no counterfeits, hazardous materials, etc.) All items must have an expected value of \$50 or more.
